# **Planning Updates**

#### Focus Groups Hosted on the Changing Federal Footprint

In partnership with the Public Building Reform Board and the Urban Land Institute (ULI), NCPC hosted four focus group sessions on the Changing Federal Footprint project. Held on November 13 and 15, the sessions will inform the agency's long-term planning on the evolving federal city and build upon the District of Columbia's approach to long-term economic vitality. Participants discussed economic opportunities that may arise from federal real estate disposition and portfolio optimization around the National Mall; identified opportunity sites and land use catalysts for disposed buildings; considered historic preservation, infrastructure, and sustainability factors needed to convert federal buildings; and proposed implementation strategies and potential organizational structures that could effectively execute conversions and prepare federally owned sites for redevelopment. Information gathered from the focus group sessions will guide ULI's Technical Assistance Panel on this important topic.

#### NCPC Participates in New DC Parks Task Force

On November 13, the Executive Director participated in the DC Parks Task Force kickoff. The task force will provide recommendations for advancing strategies to establish a trust or conservancy to support the District's parks and pursue a more efficient process to reach cooperative agreements or transfers of jurisdiction with National Park Service for federal park management. The task force builds upon policies and initiatives championed by NCPC like the CapitalSpace plan and the collaborative rehabilitation of Franklin Park. Led by key District leaders and facilitators, the task force brings together diverse stakeholders to foster inclusive dialogue and innovative strategies for sustainable, accessible parks. The task force will hold several meetings through spring 2025.



## Pennsylvania Avenue Initiative

As the holiday season approaches, event preparations are unfolding. From November 22-December 23, visitors to Pennsylvania Avenue can enjoy a short walk to the new and expanded <a href="DowntownDC Holiday">DowntownDC Holiday</a> Market, and see initial staging for the upcoming Inaugural events. The Pennsylvania Avenue project consultant teams, led by DAVID RUBIN Land Collective and HR&A Advisors, will formally kick off the design phase of the project with a walking tour of the Avenue with the project partners in early December. They will discuss how to make the Avenue a beautiful pedestrian destination and assess the event infrastructure and programming needs as they begin to refine the three early concept ideas NCPC released for public comment in 2022.



# **Public Outreach**

#### District of Columbia ULI Housing Technical Assistance Panel

On November 20 and 21, the Executive Director, Long Range Planning Deputy Director **Angela Dupont**, and Long Range Planning Director **Michael Sherman** participated in the District of Columbia and Urban Land Institute led Technical Assistance Panel (TAP) to address housing in the District of Columbia. The task force is organized by the Federal City Council, and co-chaired by Deputy Mayor Nina Albert, District Councilmember Matt Frumin, and Federal City Council CEO Mayor Anthony Willams. Specifically, the TAP will develop housing strategies that attract and retain students and early-career professionals pursuing jobs in the public service industry cluster. The TAP focused on opportunities in Downtown Washington and nearby neighborhoods that are most accessible to career and professional development opportunities in the industry cluster. These strategies will leverage the assets and resources of the federal government, universities, institutions, and businesses.



### NCPC Centennial Celebration Coming to a Close

The Centennial exhibit *Planning Washington: Capital and Community* ended its run at Arena Stage on December 3, the last venue where it was displayed. In conjunction with the display, NCPC partnered with the SWBID, Arena Stage, the DC Public Library Foundation, and DC History Tours to provide four sold-out free walking tours that considered the planning and architectural history of Southwest.
