Pennsylvania Avenue Initiative: Construction Fences Are Up

Something exciting is underway on Pennsylvania Avenue: the National Park Service has begun refreshing Freedom Plaza and John Marshall Park as part of preparations for America's 250th anniversary celebration of the Declaration of Independence. These improvements support the President's vision for a safe, beautiful, and welcoming capital city. When the refresh is completed, visitors will enjoy restored fountains, renewed seating areas, and repaired pavers and trash cans—bringing new life and elegance to some of the Avenue's most beloved public spaces. This work marks an important step in readying Pennsylvania Avenue to shine as a national stage for historic celebrations, everyday enjoyment, and moments that bring Americans together. Monumental Core Interagency Working Group Quarterly Meeting

On January 21, the Monumental Core Interagency Working Group met for their quarterly meeting. They reviewed the *Monumental Core Construction Manual*, part of the larger Streetscape Guide. The Construction Manual, which was released this month, includes details and specifications for streetscape elements found throughout the monumental core. The Working Group also discussed the Architect of the Capitol's current work on micromobility and coordinated on ongoing planning and design projects across the member agencies.



ISC-NCPC Biennial Meeting
