Monumental Core Streetscape Guide and Manual

Staff and the Interagency Working Group are scoping an update to the Streetscape Construction Manual and are continuing to develop guidelines for streetscape elements such as landscape features, pavement materials, and pedestrian zones. Staff is also addressing agency input regarding historic preservation considerations and maintenance of green infrastructure as they finalize stormwater management guidelines, At the January meeting Commissioners will hear an information presentation on the status of streetscape design guideline development, including guidelines for street lights and street trees.

Pennsylvania Avenue Initiative

Staff is meeting with key federal and local agencies to get input on a variety of physical design requirements to inform potential right-of-way configuration and programming for a broad range of high-level concept alternatives. It is anticipated that these concept ideas will be shared with stakeholders and the public for input and feedback in late fall or early winter 2021.

Comprehensive Plan: Federal Workplace and Transportation Elements

Discussions continue with the District of Columbia Office of Planning and General Services Administration regarding updates to the Federal Workplace Element's joint federal and District designated Central Employment Area and changes to the existing 60:40 federal employee policy. The element will be submitted for Commission adoption this spring once the discussions have been concluded. Staff continues to reach out to federal agencies regarding participating in the new Transportation Management Plan monitoring program.
