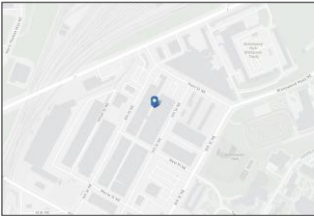




Alley Closing in Square 3701 (1.)

Planning Updates

Comprehensive Plan and Submission Guidelines

On December 7, 2023, the Commission released updates to the Comprehensive Plan's Introduction Chapter and Submission Guidelines for a 90-day public comment period that runs through March 12, 2024. The proposed Introduction Chapter updates consist of changes intended to address critical planning issues in the National Capital Region, such as equity, climate change/resiliency, and the changing federal workplace footprint.

The first step to embed equity considerations into the agency's planning work is revisions to the agency's submission guidelines. The revisions integrate equity into the review process, consistent with proposed changes to the Comprehensive Plan. NCPC will host public meetings on January 25 (online) and February 20 (in person) to present the updates and allow attendees to ask questions and provide informal comments. Pennsylvania Avenue Initiative

The Pennsylvania Avenue Initiative partners are seeking services from two consultant teams; the implementation program (IP) team will focus on economic and stewardship components of the new plan; and the master plan (MP) Team will focus on physical design and infrastructure components. In December, the Interagency Working Group (IWG) met to discuss waste receptacles, EV charging stations, and updates to lighting specifications before sending out the final draft of the Small-Scale Guidelines for final IWG review. Work is on track for Commission review and acceptance in the spring.

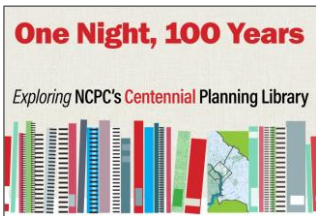




Public Outreach

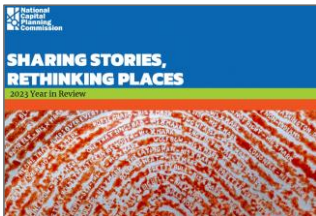
NCPC's 2024 Centennial
