Public Space and Security - Farragut Square Working Group

On July 16, 2021, the Policy and Research Division met with stakeholders including the Golden Triangle BID, National Park Service, DC Office of Planning, DC Department of Transportation, Department of Homeland Security, and Federal Emergency Management Agency to discuss funding and implementation strategies for security interventions at Farragut Square.





The Interagency Working Group met on July 29, 2021 to initiate Pedestrian Walking Space design guidelines. Staff will advance guideline development through the fall. After these design guidelines are complete, staff will return to the Commission for preliminary Streetscape Guideline review. Staff are continuing to work closely with the District of Columbia to coordinate streetscape guidelines within important transition areas between the monumental core and surrounding neighborhoods.

Transportation Management Plan Handbook



In September 2021, NCPC, the General Services Administration, and the Metropolitan Washington Council of Governments will release an updated Federal Employee Transportation Coordinator's Transportation Management Plan (TMP) Handbook. The handbook provides federal agencies with procedures and guidelines to prepare a TMP that documents their program to foster more efficient employee commuting patterns. The handbook is designed to serve as a "bridging" document between NCPC's recently adopted Transportation Element and Addendum, with more detail related to preparing, monitoring, and evaluating a TMP. Commemoration



On August 9, the Trust for the National Mall (with guidance and assistance from NCPC staff) submitted a grant proposal to the Andrew W. Mellon Foundation for a demonstration of temporary commemorative works in the nation's capital. The proposal is intended to elevate underrepresented stories in the commemorative landscape, and will bring together expert historians, multidisciplinary artists, designers, curators, and federal and city agencies to achieve this vision. If selected, NCPC staff will use the key findings from the demonstration project to inform updates to the *Memorials and Museums Master Plan* and develop new policies within the Comprehensive Plan. This proposal will be reviewed by the Mellon Foundation Board in September 2021 and notification of award (if selected) will follow.

Pennsylvania Avenue Initiative



On June 29, 2021 NCPC hosted a public panel event, *America's Civic Stage: A Vision to Celebrate Pennsylvania Avenue.* A short highlights video and its full-length format are now available at https://www.ncpc.gov/initiatives/pennave. An expert panel shared their big ideas to transform the Avenue into a more equitable, beautiful, and economically healthy corridor. This event was the kickoff to encourage public participation on the Avenue's future. Three concept visions exploring a range of physical and programming improvements will be released in winter 2021/2022 for input. The visions include: Urban Capital Street, a vibrant local street with mobile commerce and strong multi-modal transportation connections; Civic Stage, an arts, culture and entertainment destination; and Green Street, an urban linear park.

North Capitol/Irving Street Cloverleaf Workshop

On August 12 NCPC staff, in coordination with the District Office of Planning (DCOP), hosted a virtual workshop for stakeholders adjacent to the North Capitol and Irving Street intersection facilitated by the National Charrette Institute. Building off the workshop that NCPC hosted in 2019, staff reconvened representatives from the Armed Forces Retirement Home (AFRH), General Services Administration, Veterans Affair Medical Center, Catholic University, DCOP, and District Department of Transportation to exchange updates on planning work underway in the area. DCOP also presented an overview of their recent study of potential improvements to the North Capitol and Irving Street intersection. Attendees had a productive discussion regarding potential changes to the cloverleaf intersection and possible impacts/benefits to adjacent campuses and the overall area. NCPC and District staff will continue to convene this group of local and federal stakeholders to ensure a coordinated vision for the larger area. The Commission will review a master plan update to the AFRH campus this winter.



Executive Order 13690 Interagency Working Group

NCPC was invited by the White House Council on Environmental Quality and Office of Management and Budget to participate in an interagency working group to implement Presidential Executive Order 13690. This Executive Order directs each federal agency to take action to reduce risk of flood loss; to minimize the impact of floods on human safety, health, and welfare; and to restore and preserve the natural and beneficial values served by floodplains. The Executive Director participated in the first interagency meeting on Tuesday, August 24, 2021. Julia Koster will serve as our staff liaison to the working group.



Public Outreach

National Capital Region Facilities Outreach Initiative

The Urban Design and Plan Review Division was busy this summer hosting its first annual outreach meetings. Staff met with several local jurisdiction representatives and federal agencies including the Department of the Army, the Department of the Navy, the Federal Highway Administration, and the U.S. Postal Service. Additional outreach meetings are scheduled through the end of September. These meetings offered insight into projects each agency has in the pipeline for their facilities in fiscal year 2022, and were an opportunity for NCPC to brief applicants on the work completed over the last fiscal year, including how applicants should report their Transportation Management Plan data as part of the new monitoring program, which will begin this October. The Facilities Outreach Management System (FOMS) has proven to be an indispensable tool in conducting this outreach and keeping track of pipeline projects, meeting notes, and contact information.



Advancing Basic Equity Report

On August 9, NCPC provided a 200-day assessment report to the Office of Management and Budget regarding EO 13985 Advancing Racial Equity and Support for Underserved Communities through the Federal Government. The Commission will receive a briefing on this work at its September 2 meeting.
