Planning Updates

Pennsylvania Avenue Initiative

The Pennsylvania Avenue Initiative's public comment period closed on July 29, with nearly 500 comments received. The comments were posted online, along with recordings from the April 13 public meeting. In July and August, NCPC staff briefed the District of Columbia Business Improvement District Council; small and large event production companies; and enjoyed sharing the vision and concepts with the public at the Smithsonian Folklife Festival and Fiesta Asia Street Fair. Be on the lookout for the Pennsylvania Avenue table at upcoming events, including the Pink Walk, Fiesta DC, and Capital Harvest Farmer's Market. In late 2022, an information presentation will be provided to the Commission on key findings of comments received.

Monumental Core Streetscape Guide and Manual

NCPC staff completed an inventory of small-scale streetscape elements to support the development of guidelines. The Interagency Working group is preparing guidelines for trash receptacles, fire hydrants, drinking water stations, parking pay stations, electric vehicle car charging stations, and utility boxes. This winter, NCPC staff anticipate submitting the draft small-scale guidelines to the Commission for concept review and the vertical and surface elements for final review. On August 4, members of the Interagency Working Group viewed in-field mock-ups of DDOT's Smart Streetlights to provide feedback and inform development of lighting specifications for the monumental core.

Interagency Security Committee Annual Meeting

On July 20, the Executive Director and NCPC staff met with representatives from the Interagency Security Committee (ISC) as part of the ISC's annual outreach to member organizations. The discussion focused on NCPC security-specific initiatives and ISC updates.

National Capital Memorial Advisory Commission Meeting

On July 27, the National Capital Memorial Advisory Commission (NCMAC) reviewed the Smithsonian site evaluation study for the American Women's History Museum and the National Museum of the American Latino. NCMAC also reviewed H.R.6720 and H.R.6611/S.3579 that authorized the Thomas Paine Memorial Association to establish a commemorative work honoring Thomas Paine, and the Embassy of France in Washington, DC to establish a commemorative work honoring the extraordinary contributions of Jean Monnet.

Regional Plans

NCPC staff provided comments on the Draft Congress Heights Small Area Plan (CHSAP), which was developed by DC Office of Planning. The study area is bounded by St. Elizabeths and Suitland Parkway to the north; Stanton Road, SE to the east; Oxon Run Parkway, SE and Atlantic Avenue, SE to the south; and I-295 to the west. NCPC staff found the recommendations in the Draft CHSAP to be consistent with the planning principles and policies of the *Comprehensive Plan for the National Capital: Federal Elements* and the plan's vision and policies to be a thoughtful commitment to health and racial equity. NCPC staff encouraged continued coordination with applicable federal agencies to implement the plan's goals.

Brown-Bag Presentations

As part of NCPC's ongoing efforts to incorporate equity, diversity, and inclusion into our daily work, two brown-bag presentations were conducted with speakers to better understand the efforts of other regional planning organizations. On August 4, **Tanya Stern**, Deputy Director with Montgomery County's Planning Department, presented the various ways her organization has incorporated equity into their analyses, review documents, and outreach. On August 24, **Anita Cozart**, Interim Director; **Deborah Crain Kemp**, Community Planner; **Martin Brown**, Capital Facilities Planner; and **Maxine Brown Roberts**, Development Review Specialist; **Jessica Williams**, Community Planner; and **Jordan Chafetz**, Capital Facilities Planner from the DC Office of Planning presented their equity work in relation to their capital improvements program, comprehensive plan, and small area plans.



Public Outreach

Regional Facilities Outreach Program

The Urban Design and Plan Review Division has been busy this summer hosting its annual outreach meetings. Staff met with several local jurisdiction representatives and federal agencies to discuss projects anticipated for Fiscal Year 2023, including the Defense Intelligence Agency Headquarters Annex, the Joint Base Myer-Henderson Hall Army Family Housing Master Plan, the East Parklands Rehabilitation, the Pentagon Master Plan, and the Arlington National Cemetery Master Plan. Additional outreach meetings are scheduled through the beginning of October with a few remaining federal agencies. These meetings have also offered a valuable opportunity for NCPC to brief applicants on the work staff completed over the last fiscal year, including NCPC's Equity Action Plan.
